Dear Members of the AIR Awards Committee,

It is with distinct honor that I write this letter to nominate Dr. William E. Knight (Bill) to receive the 2022 AIR John Stecklein Distinguished Member Award posthumously. As you will see from the information contained in this nomination packet, Bill meets and, in most cases, exceeds all of the criteria outlined for the Stecklein Award. There is no question that Bill had an exemplary professional career that significantly advanced the field of institutional research through extraordinary scholarship, leadership, and service.

Bill epitomized the collegial and collaborative spirit that is associated with institutional research and the profession. To say that Bill was an active member of AIR is an understatement. Bill was an engaged, contributing, visionary, global leader of AIR that will have long lasting effects on the IR profession. Bill was a member of AIR since 1989 and his involvement included serving as President in 2008-2009, At-Large Member of the AIR Board of Directors, Forum Chair, instructor for AIR professional development courses, past member of the *Professional File* editorial board and the publications committee, and associate editor for the *Resources in Institutional Research* publications series. Bill was a regular contributor to *eAIR* and a regular presenter at the AIR Forum. Bill was the recipient of the 2013 AIR Outstanding Service Award.

Bill was also actively involved with regional associations such as the Indiana Association for Institutional Research, the Northeast Association for Institutional Research, and the Ohio Associational for Institutional Research and Planning where he served as President in 1999-2000. His professional service also included the International Coalitions for Electronic Portfolio Research, the National Study of Instructional Costs and Productivity Advisory Committee, the University System of Georgia Administrative Committee in Institutional Research and Planning, and the University System of Georgia Task Force on Assessment Methods, as well as the regional accreditation association, Higher Learning Commission, where he served as a Peer Reviewer since 1999 and was also trained as a Team Chair. In addition, Bill was the founder of

The Doctoral University Data Exchange and co-founder of the Association for Higher Education Effectiveness where he served as President and a member of the Board of Directors. Bill also served as a consultant on matters related to institutional research, assessment, and accreditation.

Bill made countless significant contributions to the field of institutional research. These contributions include, but are not limited to, the following:

Four prominent publications that Bill either authored or edited [Leadership & Management in Institutional Research: Enhancing Personal and Professional Effectiveness (2014), Building Bridges for Student Success: A Sourcebook for Colleges and Universities (2013), The Handbook of Institutional Research (2012), and The Primer for Institutional Research (2003)] are regularly cited and/or used to guide the work of IR professionals around the world.

Bill was a visiting scholar on two occasions. First in 1992 at the University of Michigan with the Higher and Adult Continuing Education/Center for the Study of Higher and Postsecondary Education Program. Second in 2008 at the Institute of Higher Education in Jinan, China.

Bill's influential contributions have had a direct and positive impact on the IR profession. Bill took full advantage of the opportunity for institutional researchers to be change agents and was a change agent himself. Generations of IR professionals to come will benefit from Bill's scholarship and innovative ideas.

It is an honor to write in support of Bill Knight for the John Stecklein Distinguished Member Award. Bill's service to the profession epitomizes all that I think of when envisioning a distinguished member. He taught, he was a prolific writer, he mentored numerous students and professionals, he served the Association in multiple roles including Forum Chair and President, and he was a kind and generous human.

Bill was a fixture at the Forum - always presenting, always encouraging others, and just there to talk through the issues of the day. He cared deeply for both AIR and the IR profession, and his immense knowledge of the field was demonstrated in the 2003 *Primer for Institutional Research* which he edited. But Bill didn't stop with the basics, in 2014 he authored Leadership and Management in Institutional Research, creating a handbook for those seeking to advance in the field.

When Bill passed away last year, the outpouring of support and tributes to him demonstrated that he wasn't just a scholar or a leader but he was a kind friend and familiar face to so many. I recall being in Indianapolis for a (non-IR) conference and hearing my name called across a hotel lobby as I was checking out. It was Bill, in the same hotel for the Indiana AIR conference, calling me over to introduce me to his state colleagues and make new connections for them. He made connections like that for his students, for his OCAIR colleagues, and for anyone who indicated they were new and wanted to learn the profession. It is a special skill - connecting others, calling out similar interests or skills.

I think my last conversation with Bill was in July of 2020, when we caught up with each other over Zoom to talk about Tableau dashboards. Even though he was in a campus leadership position (Associate Provost), Bill was still digging into learning Tableau and creating his own dashboards - he led by doing. He had asked for our advice about one topic and then allowed us to pick his brain about another. That was Bill - always willing to I earn from others, never believing he had all the answers, while simultaneously willing to share what he knew.

In summary, it is my sincere hope that you will honor Bill with the Stecklein Distinguished Member award. I cannot think of a more deserving candidate.

Nomination for the John E. Stecklein Distinguished Member Award

Dear Members of the Award Selection Committee:

It is my honor to support the nomination of Dr. William (Bill) E. Knight for the John E. Stecklein Distinguished Member Award. Bill's many contributions to our field have positively impacted countless numbers of professionals at a variety of stages of their careers.

Bill's career trajectory allowed him to broaden his expertise across the domains of institutional research, effectiveness, and leadership. His three decades of experience at Kent State University, Georgia Southern University, Bowling Green State University, Ball State University, Miami University and service in the international sphere at Shandong University provided him with an array of perspectives and experience to share with any who asked for help, advice, or mentorship. A recipient of the AIR Outstanding Service Award in 2013, Bill continued to serve our field in ever greater capacities in the years that followed in ways which I will discuss herein.

Bill's service to his profession includes state and national level leadership roles. He served as President for the Ohio Association for Institutional Research and Planning as well as on AIR's Board of Directors (President in 2008–2009) and Chair of the AIR Forum Committee. Bill also was the Co-Founder and served as President and a Board of Directors member for the Association for Higher Education Effectiveness from 2013 to 2018.

It was apparent upon first meeting Bill at the AIR Forum in 2012 that his purpose was to help others and he brought this perspective to any meeting, workshop, presentation, and conversation. His contributions to the institutional research community include seminal works such as *The Primer for Institutional Research* (2003) and *The Handbook of Institutional Research* (2012). Each of these works contributed greatly to my own professional development and are regularly referenced by my colleagues as go-to resources.

In addition to the written word, Bill was always ready to engage with others in supporting their professional growth. In the years I knew Bill, he provided quality presentations (usually more than one) at every AIR Forum from 2012-2020 that spanned IR, IE, and accreditation. Due to our busy schedules, we often found time to chat in the minutes leading up to a pre-conference workshop and this was when I received much of the wisdom that I would continue to rely upon after returning to the office.

Bill also focused on the evolution of the leadership potential within IR and IE. Not only did he model what an executive level team member should know and do, but he devoted his later years to helping others become effective leaders. *Leadership & Management in Institutional Research* (2014) happened to be published just as I was considering my next steps and it gave me the confidence and clarity to take on a director's role. The IR profession is fortunate to have

many people willing to lead and mentor the next generation and Bill has had a remarkable influence on my own professional goals and achievements.

Bill was an active member of AIR and has made substantial contributions to the field of institutional research by supporting the training and development of IR practitioners, promoting the application of IR theories and practices, and advanced the practice of institutional research through innovative ideas. I believe my testimony provides evidence herein to support this nomination.

I recommend without hesitation that Bill Knight's professional legacy be continued through the posthumous awarding of the AIR John Stecklein Distinguished Member Award.

### Dear Colleagues:

It is my privilege to provide a letter of support for William (Bill) Knight for this year's AIR Distinguished Member Award, all too sadly posthumously. I would be even more delighted if Bill were still here to be acknowledged by the AIR community for his longstanding, significant, and deeply impactful contributions to the profession and the community of practitioners.

I am one of many institutional researchers who can say that Bill Knight was a friend and close professional colleague. I got to know him well in the first decade of the 2000s, when we both served on the AIR Board, did several IR consults together, and then became Indiana colleagues when he took the helm of Ball State's IR and Assessment operation in 2011. He has been a regular guest in my IR class and always added substantive and inspirational value to the class, as he did to all the work he touched.

As a campus IR practitioner, Bill helped to develop to highly effective institutional research offices Georgia Southern University, Bowling Green State University, Ball State University, and finally, Miami University of Ohio. He re-built two of these three operations (Bowling Green and Ball State) from the ground up. These IR operations were well known for their effectiveness and leading edge practices, in large part because of Bill's unique combination of knowledge, people skills, and passion for the work.

Bill was a fixture at AIR conferences, is a past president, and has won the Association's outstanding service award. He was always highly involved in the annual Forums, giving several presentations and generously spending time engaging with colleagues across the spectrum of experience. His name is found across the full range of AIR publications, from Professional Files to New Directions chapters, and, as somewhat

of a capstone, his AIR volume, "Leadership and management in institutional research: Enhancing personal and professional effectiveness." Within this volume, Bill explains the basis of his viewpoint, which I think captures well his distinction in the field:

When I frame this book as being about leadership and management in IR, I really mean within the set of affiliated responsibilities that Leimer (2011b) and others have termed institutional effectiveness. I use the term "institutional research" in this book because it is being published by AIR and because I will always think of myself as an institutional researcher at the core. Along the way I have had the opportunity to serve as AIR's forum chair, president, and member of its board of directors. I edited the Primer for Institutional Research (Knight, 2003), and with Rich Howard and Gerry McLaughlin served as coeditor of the Handbook of Institutional Research (Howard et al., 2012). I have had the opportunity to be a peer reviewer and team chair for the Higher Learning Commission. Currently, I direct Ball State University's IR Certificate Program. I hope these experiences have given me a sufficiently broad perspective to offer a book about leadership and management in IR. I have tried to be sensitive to differences in sectors and office responsibilities. Nevertheless, we are all a sum of our experiences, so any lack of applicability to certain circumstances is a limitation I acknowledge."

Bill's life was cut short: he was in his mid-50s. The profession will no longer have the benefit of his continually expanding wisdom, but he has left so much behind to help us all find the drive, commitment, initiative, and especially optimism to continue his quest to improve the craft of institutional research to serve higher education institutions. He deserved this award during his lifetime, but we can only do the next best thing and recognize him posthumously.

We were shocked and saddened by the loss of our colleague, Bill Knight, last spring. His untimely passing left a void in our profession and the Association for Institutional Research (AIR) that cannot be filled. Consequently, I was shocked to learn that we had missed the opportunity to honor Bill with the John Stecklein Distinguished Member Award while he was with us. I was certain he had been a recipient given his long history of service and contributions to AIR as a leader, mentor, and friend but I was proven wrong. This opportunity to honor him posthumously should happen without delay.

The Stecklein Award recognizes those who have made substantial contributions to the field of institutional research by advancing the practice through innovative ideas, techniques or theory. I met Bill in 1995 when he was the director of Institutional Research at Georgia Southern University. Since that time, he has been a constant source of ideas, leadership and inspiration. He checks every box required for the Stecklein Award which recognizes a member whose professional career has significantly advanced the field of institutional research through extraordinary scholarship, leadership and service:

- ✓ Active member of AIR. I'm not sure exactly when Bill joined AIR but he has been a fixture at the Annual Forum for as long as I can remember (maybe the mid-1990s?). He has served as track reviewer, presenter, workshop leader, facilitator, Forum chair, and president of AIR.
- ✓ Advanced the practice of institutional research through innovative ideas, techniques or theory. In 2003, Bill edited "The Primer for Institutional Research." Then in 2012, Bill joined two giants in the IR field, Gerry McLaughlin and Rich Howard, to produce "The Handbook of Institutional Research", a foundational and influential work which is a must-have resource for all practitioners. In "Leadership & Management in Institutional Research", Bill single-handedly wrote a book that served as a thought-provoking guide for current and future IR directors.
- ✓ Contributed to widely-disseminated research. Prior to and after the books, Bill was published in journals from *New Directions in Institutional Research* to *Canadian Journal of Nursing* to *Journal of Applied Psychology*. His works are varied and often-cited, which is evidence of a strong contributor to scholarly activities inside and outside of institutional research.
- ✓ Supported the training and development of IR practitioners. I will include myself in the large group of people mentored by Bill Knight. His encyclopedic knowledge of institutional

- research and his overwhelmingly kind and calm personality made him the ideal person from whom we could learn about leadership and emotional intelligence. His "Leadership and Management" book was the ultimate gift to the training and development of IR practitioners.
- ✓ Promoted the application of IR theories and practices in new venues and/or organizations. Bill was one of the organizing directors for The Association of Higher Education Effectiveness (AHEE) which provided a resource to higher education professionals who integrate multiple functions such as institutional research, strategic planning, assessment, accreditation, and program review. He served as a peer reviewer and team leader for the North Central Association Higher Learning Commission.
- ✓ Demonstrated the contributions of institutional research to policy formation. Bill wrote several articles regarding the importance of having institutional researchers at the table when policy decisions are made. His book chapter in "Building Capacity in Institutional Research and Decision Support in Higher Education" (Karen Webber, ed.) covered conceptual models and organizational intelligence for IR practitioners and provided a roadmap for colleges and universities to use institutional research to the greatest advantage.

Bill Knight's impact continues to be present today and considering his body of work, that impact will continue for generations to come. Honoring him as the John Stecklein Distinguished Member in 2022 would be a perfect way to recognize this wonderful colleague who was also the kindest of gentlemen and exemplar of leaders. Re: Recommendation for Distinguished Member Award

It is an honor to write this letter of recommendation for the 2022 John Stecklein Distinguished Member award for William Knight. It also comes with great sadness to write this letter and hopefully have Bill receive this award posthumously. Bill was a long-serving AIR member who contributed greatly to the Institutional Research profession. The first qualification for the award states that the candidate must have been an active member of AIR and have made substantial contributions to the field of institutional research over an extended period of time. Following his death, Dr. Knight was honored with so many tributes over social media and through our association that documented his contribution to our field. Over the years, Bill has served in numerous leadership roles for the association, including serving as member of the AIR Board of Directors, and serving as President of the Association in 2008-2009. I also witnessed Bill's leadership as he served as President-Elect, while I served as President in 2007-2008 and I was honored to serve as Past President during his presidency. To say that Bill is a thoughtful and caring leader is understatement. His personal style and dedication to the association was a cornerstone of his leadership and service to the association.

The second criteria for this award states that through research, service, and/or practice the candidate must have made a significant contribution to the field of institutional research in two or more of the specified areas. While I believe that Bill has provided significant contributions to all of these areas, I will speak directly to two areas: contributed to widely-disseminated research and supported the training and development of IR practitioners. To say that Bill has contributed to widely disseminated research is an understatement. I write to express my strong support for posthumously awarding the John Stecklein Distinguished Member Award to Dr. William Knight. Although he passed away in April 2021, his dedication and long-time work in the field of Institutional Research amply qualifies him as a member whose professional career significantly advanced the field of institutional research through extraordinary scholarship, leadership, and service.

Bill was a leader in multiple facets of institutional research and institutional effectiveness. His professional interests included the impact of college on students and leadership and effectiveness. He also served as an at-large member of the AIR board of directors as well as chair of the Forum Committee. In response to his myriad contributions, Bill was the 2013 recipient of the AIR Outstanding Service Award.

Bill was not only a dedicated and esteemed IR practitioner, he was also a scholar. Dear Heather,

Thank you for your message. It's great idea for you to nominate Bill Knight for John Stecklein Distinguished Member Award. To support you, I drafted a few words below.

Bill hired me at Bowling Green State University (BGSU) in 1997. During the campus interview, Bill told me that there was no IR office at BGSU at all before he had come to BGSU a year ago. A professor and a graduate assistant from the Higher Education Department worked on IPEDS reports which were mandatory by the federal law. That means Bill was the founding member of the Office of Institutional Research at BGSU.

Since then, I had worked with Bill for 14 years. I really learned a lot from Bill during that unforgettable time. One of IR routine projects I learnt from Bill is Student Flow Model, that Bill created for tracking new students' retention rate and graduation rate. Whenever I had problems on some IR projects, Bill would be very patient to help me solve the problems. For example, when I first took the project of Delaware Faculty Workload Studies, I didn't know how and where to get the research fund information which made me very frustrated. Bill was very nice and very patient to guide me step by step including when and where to get the information and how to distinguish the restricted fund and the unrestricted fund.

Bill paid attention to the professional development of the IR practitioners. He encouraged me not only to attend AIR annual forum and regional/state IR conference but also to participate in the activities in the forum/conference. Bill taught me how to write a proposal to present a paper/poster/workshop in the forum/conference. When Bill found that I was shy to speak publicly because my native language was not English, he always pushed me to speak out in front of audience. He was really an excellent tutor.

In 1998-99 academic year, I was the Chair of Overseas Chinese Association for Institutional Research (OCAIR), which was established in 1996 as an AIR-Special Interest Group (SIG). One of goals in my tenure of office was to promote the OCAIR from AIR-SIG to AIR Affiliate. Bill gave me great assistances by introducing me to some leaders in other AIR affiliates in state and/or regional level, such as OAIRP, NEAIR, etc. Therefore, I could learn how to prepare the documents for applying the AIR Affiliate for OCAIR. Before submitting all the applying documents including organization's constitution and bylaws, member lists, cover letters, etc., Bill helped me to review and to edit the final version of all documents. With Bill's great contribution, OCAIR finally was approved by AIR Board as a new AIR Affiliate in 1998. I and all OCAIR members appreciated Bill very much.

I met Dr. Knight when I started my IR career back in 1997 at Ohio State. Over the years, throughout his journeys at Bowling Green, Ball State and Miami universities, we stayed connected. Bill showed great interest in helping young professionals and he always made time to offer ideas and suggestions for projects and presentations. Like many others, I had benefited from Bill's generosity and intellectual prowess. As I am writing this letter, I kept remembering all the funny jokes, witty quotes, and great presentations that he had made.

For this letter of support, I would like to emphasize the substantial contributions that he made to the field of institutional research. For someone whose signature block often carried the quote "if you torture the data long enough it will confess to anything", Bill was a thoughtful scholar with a deep commitment to enrich the theoretical and applicational foundation of IR. Based on Google Scholar, Bill authored or co-authored more than 36 peer-reviewed and invited publications, including *Leadership and Management in Institutional Research: Enhancing Personal and Professional Effectiveness*, edited the *Primer for Institutional Research*, served as co-editor of *The Handbook for Institutional Research and Building Bridges for Student Success.* Over the years, I had not been to any regional or national meetings without seeing Bill making a presentation, sitting on a panel, or moderating a discussion. Bill was one of the most prolific contributors to intellectual conversations on how institutional research could transform to adapt to the changing landscape and demands of higher education. His scholarly contributions left a deep footprint that will continue to influence our thinking and practices of institutional research for many years to come.
