

Julie's service to the field of institutional research (IR) cannot be overlooked as her contributions are many and they are significant. From the publication of scholarly articles on a variety of relevant topics to the mentorship of numerous IR professionals to the leadership of several IR-related organizations, including the Association for Institutional Research, Julie's candidacy for this award is compelling. 

It was then that I noticed the special way that Julia engages with colleagues. Her kind disposition and attentiveness to others' views made project meetings enjoyable and productive.
