Code of Conduct

AIR invites you to attend the AIR Forum, our annual conference, in the collegial spirit of learning, sharing, and networking with open-mindedness and respect.

Attendees must behave responsibly at all events. Threatening physical or verbal actions, disorderly or disruptive conduct, and harassment, intimidation, threatening speech, or discrimination in any form, including (but not limited to) relating to race, gender, gender identity and expression, national origin, religion, disability, body size, marital status, age, sexual orientation or any other protected category, or inappropriate use of nudity and/or sexual images in presentations, .

Such behavior may result in removal from the meeting (whether in-person or virtual), denial of access to meeting facilities, virtual platforms, and other penalties.

These behaviors do not belong at the AIR Forum:

- Disrespecting, heckling, or disrupting a session.
- Being disruptive or drinking excessively at social functions.
- Stalking, following, threatening or disrespecting the boundaries of other attendees.
- Abuse of power (including abuses related to position, wealth, race, or gender).
- Any behavior that discriminates against a group or class of people or an individual.
- Harassment of any kind.
- Aggressively advocating your own services, products or causes.

Statement on Diversity, Equity, and Inclusion
