#### Section 1 - President's Report

On behalf of the Board of Directors of the Association for Institutional Research, I am honored to present the 2014–2015 AIR Annual Board of Directors Report, to you, our colleagues and fellow members. We began our work at the Annual Forum in Orlando, Florida. Building upon the strong foundation laid by previous Boards, we set forth an agenda with a more mature insight into Policy Governance and began focusing on positioning AIR for the future.

One of the first actions by the Board was to gather feedback from the membership on the Ends statement. After reviewing the comments, the Board revised the Ends statement and set a clear purpose for current and future Association activities. Thank you to all who contributed to this process.

AIR exists so that higher education institutions effectively use institutional research data, information, and analysis for decision support in a rapidly changing environment. This must be done within AIR's available resources.

- Institutional researchers have knowledge and skills necessary to perform the duties and functions of
  institutional research, including: methods and tools; internal institutional effectiveness; external
  accountability; professional and interpersonal skills; and research and scholarship.
- Higher education leaders view institutional research as essential.

Several committees continued or were appointed to address areas specific to the Board operations or to explore what our association might resemble in the future. The *Research in Higher Education* Committee continued their work reviewing the Board's relationship with publications that use AIR's name. The work of the committee led to Board action on the continuance of the long-standing relationship between AIR and *Research in Higher Education*. The Committee on the Future of Associations is focusing on the challenges facing associations in general, but specifically how AIR might address its future in order to meet the needs and expectations of its members. The Nominations and Elections Advisory Committee is reviewing the nominations and election process and its alignment to policy governance. In addition to these special purpose groups, there are two standing committees, the Nominations and Elections Committee and the Audit Committee. Their work is reported in greater detail in Section 2 and Section 4 of this report.

All of us working together to further the IR profession is what it's all about. AIR is stronger than ever because of our community of practice.

#### Section 2 - Financial Report

While the AIR Board as a whole is responsible for overseeing the financial health of the organization, the Board has delegated specific leadership responsibilities to the Board Treasurer, Heather Kelly, for 2014–2015. The Board Treasurer provides leadership for the independent annual audit, including serving as chair of the Board Audit Committee, which annually reviews the Financial Statements and findings from an independent audit firm concerning the financial state of the Association. The Board Treasurer is also responsible for presenting an annual report of AIR's financial condition at the Annual Forum. The Board Treasurer ensures that the Board has sufficient information to make sound financial policies. Three of the CEO Monitoring Reports reviewed and discussed by the Board deal specifically with the Association's (1) financial planning, (2) financial condition and activities, and (3) asset protection, and evaluate how the CEO handles the executive limitations set by the Board.

The governance policies and executive limitations set by the Board related to finances provide a level of protection, set boundaries, and serve as a warning mechanism not realized prior to board governance.

A Board Audit Committee annually reviews the Financial Statements, as well as the Management Letter produced by an independent firm charged with auditing the financial position and the related statement of activities, functional expenses, and cash flows for the past year. The Board Audit Committee reviews with the Executive Office those audit findings which cite any compliance issues or opportunities for ways to improve internal controls and operating efficiencies of the Association. The Board Treasurer distributes the annual audit draft and the Committee's findings to the Board for review and acceptance.

The firm of Purvis Gray & Company, Certified Public Accountants of Gainesville, Florida, audited the December 31, 2014 and 2013 financial statements of the Association. The auditors issued a clean audit and indicated that the audit disclosed no instances of significant deficiencies and/or material weaknesses in internal control. Further, the auditors commented that the organization is in a very healthy financial position.

The December 31, 2014 audit was discussed by the Audit Committee on April 27, 2015 and the Board accepted the audit draft on May 14, 2015. Key findings on the current financial health of the Association:

- 1. Unmodified 2014 audit issued on the Financial Statements with no reportable instances of significant deficiencies or material weaknesses in internal control and no material instances of noncompliance.
- Unmodified 2014 audit issued on the Major Federal Award Programs with no reportable significant
  deficiencies or material weaknesses in internal control over major federal programs and no findings required
  to be reported.
- 3. Revenues exceeded expenditures by \$618,838 in 2014. The current total net assets of \$3,948,518 is the largest annual net reserve in the history of the Association.

#### Section 3 – Ensuring the Health and Vitality of the Association

The AIR Board of Directors has several core responsibilities, including determining the Association's Ends; ensuring resource availability, asset protection, and overall accountability; and continuously improving governance capacity. Below is a summary of Board activities related to these responsibilities.

#### Ends Policy - AIR's Purpose

During 2014, the AIR Board of Directors spent much time ensuring that the Ends policy was timely, relevant, and meaningful. The work of the "Framing the Ends Policy Discussion Working Group" served as the linchpin for the new Ends policy that was unveiled during the 2014 Forum. The Board sought feedback from the membership over the summer and during the August 2014 Board of Directors meeting in Indianapolis, the new Ends policy was adopted. The policy reads as follows:

AIR exists so that higher education institutions effectively use institutional research data, information, and analysis for decision support in a rapidly changing environment. This must be done within AIR's available resources.

- Institutional researchers have knowledge and skills necessary to perform the duties and functions of institutional research, including: methods and tools; internal institutional effectiveness; external accountability; professional and interpersonal skills; and research and scholarship.
- Higher education leaders view institutional research as essential.

Stephen Covey advised us to "begin with the end in mind" in *The 7 Habits of Highly Effective People*. The new Ends policy allows AIR to do just that. The Board monitors the accomplishment of the achievement of the Ends annually (late summer).

## Resource and Asset Protection Monitoring – Ensuring the Continued Financial Health of the Association

The Association's Governance Policies describe unacceptable means for achieving the Ends. These policies, called Executive Limitations, are monitored by the Board on an established schedule. Below is a list of reports and activities related to continuous financial monitoring by the Board over this past year. The monitoring reports mirror the findings in the Section 2 - Financial Report – that AIR is financially sound.

#### Board Leadership and Planning for the Future of the Association

The Board of Directors is committed to a governing style that is in accordance with Association's Constitution and Bylaws and Governance Policies and emphasizes good governance practices, an outward vision, an appreciation of diverse viewpoints, and proactivity rather than reactivity.

One approach to being proactive is to constantly maintain and review our governance policies to ensure expectations are clear and current.

This year, in addition to revising the Ends policy, the Board updated EL II Treatment of Members, GP II Governing Style, GP XI Cost of Governance, GP X Board Committee Structure, GP VII Board Treasurer's Role, and BRC IV Monitoring CEO Performance.

The Board of Directors established two new Board committees during 2014–2015 to support and bring a variety of perspectives to issues facing the Board. These committees were the Committee on the Future of Associations and the Nominations and Elections Advisory Committee. The *Research in Higher Education* Committee continued its work into this year. A summary for each committee is provided below.

#### Research in Higher Education Committee

The committee was formed in spring 2014 to review the memorandum of understanding between the Association for Institutional Research and Springer publishers regarding *Research in Higher Education (RIHE)*. The committee included Gayle Fink, Sandi Bramblett, Mauricio Saavedra, Hansel Burley, and Gary Pike. Committee members met several times via teleconference to discuss AIR's continuing relationship with Springer and *RIHE*. The committee also shared its findings with the AIR Board of Directors and the Executive Office. The committee was also in communication with representatives of Springer and Dr. Robert Toutkoushian, past president of AIR and editor of *Research in Higher Education*. During the Board's face-to-face meeting in March 2015, the Board held a teleconference with Rob Toutkoushian, and subsequently directed AIR's Chief Executive Officer to negotiate a new memorandum of understanding with Springer in order to continue the long-standing relationship between AIR and *Research in Higher Education*.

#### **Committee on the Future of Associations**

Given the change in the professional world and the expectations that members have about professional development, a small group of AIR members and a representative from the Executive Office are reviewing writings and sharing their findings and their personal insights into the future of professional associations. This group represents a wide range of years of experience in institutional research and related activities, varied amounts of involvement in the Association, and different types of institutions and positions. They are focused on the challenges facing associations in general, but specifically how AIR might address its future in order to meet the needs and expectations of its members. The group will prepare a report for the Board of Directors for its review as it considers the strategic direction of the Association. The report will be presented to the Board at its meeting at the Forum in Denver.

Other Board future focused activities included reviewing characteristics of other higher education member associations, discussing services attractive to the millennial member, and discussing possible membership models.

#### **Nominations and Elections Advisory Committee**

The Nominations and Election Advisory Committee was formed in March 2015 to review the nominations and election process, determine its alignment to policy governance, and to provide recommendations for Board action. Members of the committee include Gayle Fink, Gary Pike, and past Nominations and Elections Committee Chairs under Policy Governance, Sandi Bramblett, Jennifer Brown, Julie Carpenter-Hubin, and James Trainer. The Advisory Committee, Randy Swing, and Christopher Coogan met at the end of April to review the Constitution and Bylaws related to nominations and elections, examine current governance policies, review recent election data, and share strengths and challenges of the current process. Several recommendations from this group will be shared with the Board in May 2015.

Over the past year, the Board supported good governance practice by electing a Treasurer, Secretary, and Parliamentarian, developing a process for identifying a replacement for a Board member who resigned, supporting further Carver Policy Governance Training, evaluating the May 2014 Board Orientation program, establishing a Board budget, revising as necessary governance policies, and piloting a different Board self-evaluation process.

#### Section 4 – Immediate Past President/Nominations and Elections Committee Chair

It is my pleasure to submit this report on behalf of the 2014–2015 Nominations and Elections Committee (NEC) for the Association for Institutional Research. My heartfelt thanks goes to the six AIR members who served on the NEC: Michelle Appel (University of Maryland), Timothy Chow (Rose-Hulman Institute of Technology), Jan Lyddon (Organizational Effectiveness Consultants), Soon Merz (Austin Community College), Kathy Schmidtke Felts (University of Missouri-Columbia) and Rick Voorhees (Voorhees Group, LLC). These six wonderful colleagues took their roles very seriously and it was a privilege to serve with them. We were supported by Lisa Gwaltney from the AIR Executive Office. Her experience, organizational skills, and keen insights were critical to the success of the NEC and we owe her a debt of gratitude for her contributions to our work.

Over 100 names were submitted during the nominations process with 40 members completing the required nominations package for consideration by the NEC. Interviews of potential VP candidates took place and a thorough review of all of the nominations packages was conducted to determine the final slate for election. The vote was conducted in February 2015 with the following members called to serve: Glenn James (Vice President); Clifford Adelman, Kara Larkan-Skinner and Jessica Shedd (Members-at-Large); and Marne Einarson, Denise Gardner, and Zhao Yang (NEC members). #### Section 5 - Membership
