**Volunteer Leadership Pathways Committee.** Christopher Peña shared that the committee's next steps include sharing recommendations with the Board in early 2024.

**Governance and Orientation Committee.** Jonathan Gagliardi led conversation about what's needed in the future for policy governance training in terms of modalities, length of training sessions, scheduling, and facilitators.
