“Niche” College Defined and Why We Are Reviewing It


- For purposes of this presentation a niche college is one technically in a given *sector* but which reports and displays data in a different sector.
- “Niche” colleges are the exception, and overall data collection doesn’t impact some of the big picture data IPEDS collects. However, it is important sometimes to know that there are these exceptions.
- “Niche” colleges for purposes of this presentation are those that are public two-year with highest degree available being a four-year degree.

Identifying “Niche” Colleges


- For purposes of this presentation Carnegie Classification was used to identify “Niche” colleges.
- The 2000 edition was the first to introduce the classification “Baccalaureate/Associate's Colleges.”
- The 2015 edition introduced “Baccalaureate/Associate's Colleges: Associate's Dominant.”
- The data regarding “Niche” colleges in this presentation are based on the 2018 Carnegie Classification Baccalaureate/Associate's Colleges: Associate's Dominant.


How “Niche” colleges fit into the IPEDS Sectors

History of Niche Development

A policy brief from New America provides some context to the development of the “niche” sector, public 2-year colleges offering a baccalaureate degree.


- West Virginia was the first state authorizing this offering beginning in 1989. Authorizations have accelerated within the last decade, and particularly within the last five years.
- Some states authorize all public 2-year colleges to offer baccalaureate degrees, while others limit the authorization by institution.
- Authorization generally requires demonstration of the benefit of offering a particular program as baccalaureate.
- In addition to state authorization, regional accreditation body approval is generally required.



GRADUATION RATE REPORTING DATA CYCLE AND AVAILABILITY

The outcome is a degree or certificate within 150% of expected time for program completion.

This means within about one to three years depending upon the minimum amount of credits required to complete the program.



- IPEDS Keyholder is often not the Reports Coordinator
- Total Estimated FTE for the Florida College System is 278,139.
 - Low: 960
 - High:42,151

Perspective of State System College with Centralized IPEDS Reporting versus a College with Independent Reporting

- The 28 Florida Colleges are independent organizations, however, IPEDS reporting is semi-centralized.
- IPEDS Reporting for the Florida College System falls under the supervision of PERA (Bureau of PK-20 Education Reporting and Accessibility).
- Reporting responsibilities for IPEDS are shared by the college and the Florida DOE via a hybrid methodology.

- The survey population must match past submitted data which is based on that year's EF2 (Fall Enrollment) File.

Graduation (150%) Rate Calculation

- The FCS Institutions offer both clock hour programs and credit hour programs.
- Expected time for completion is based on the Award Type submitted in the Student Database Completer Record.
- Time for completion at 150% ranges from 3 semesters to 9 semesters.

IPEDS Fall Enrollment Survey – First-Time Bachelor’s Cohort (Part E)

- Baccalaureate Degrees were statutorily legislated in Florida to allow colleges to offer workforce bachelor’s degrees.
- In order for a student to enter a baccalaureate program (6A-10.030) they must have already earned an Associate Degree (60 credits) and the required English, Writing, and Math courses.
- Historically, Florida Colleges never had “true FTIC” students entering into baccalaureate programs because they had to complete their AA prior. Baccalaureate students were considered transfers or returning students.
